Routes to qualifying

Candidates with no prior degree

If you already work in a legal office, you can join the **Chartered Institute of Legal Executives (CILEx)**, which is the governing body for chartered legal executives. You must pass examinations to qualify first as a member and later as a fellow. Qualifying by this route takes a long time, is demanding and academically challenging, and requires that you enter and maintain CILEx-approved legal employment. The CILEx examination framework enables you to fulfil the requirements of the academic stage of training, including the foundations of legal knowledge.
